RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of April 29, 2013 ("Effective Date") by and among R.H. Donnelley Inc. , a Delaware corporation, located at 1001 Winstead Drive, Cary, North Carolina 27513 (the "Grantor") and Deutsche Bank Trust Company Americas, a United States chartered bank, located at 60 Wall Street, New York, New York 10005 (the "Collateral Agent").

WHEREAS, Grantor, Lenders and Collateral Agent have entered into that certain Third Amended and Restated Guarantee and Collateral Agreement, dated as of January 29, 2010 (as amended and restated or otherwise modified from time to time, the "Collateral Agreement");

WHEREAS, pursuant to the Collateral Agreement, Grantor, R.H. Donnelley Publishing & Advertising, Inc. and Collateral Agent entered into that certain Grant of Security Interest in Trademark Rights, dated as of January 29, 2010 (the "Trademark Security Agreement" all capitalized terms used, but not defined, herein have the definition assigned to them in the Trademark Security Agreement);

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, Grantor pledged and granted to Collateral Agent a continuing security interest in the Collateral (including, without limitation, the United States trademark registrations, trademark applications and licenses set forth on Schedule A attached hereto), in each case, together with the goodwill associated therewith (collectively, the "Trademark Collateral"); and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 29, 2010 at Reel 4140, Frame 0507.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, without recourse and without representation and warranty, Collateral Agent hereby (i) terminates, cancels and releases any and all security interests it has against the Trademark Collateral, and (ii) terminates the Trademark Security Agreement.


Collateral Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.


Collateral Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks to record this Release.
