**NOTICE OF RELEASE OF  
SECURITY INTEREST IN UNITED STATES TRADEMARKS  
(PULITZER, INC.)**

The Collateral Agent agrees, at the Assignor's expense, to cooperate with the Assignor, to execute, deliver and file any additional documents, and to provide the Assignor with the information and additional authorization reasonably required or desirable to effect the release, relinquishment or discharge of the Collateral Agent's security interest in the released collateral described herein.
