**ASSIGNMENT AND RELEASE OF
SECURITY INTEREST
(Trademark Release – Second Lien)**

April 30, 2013

This Assignment and Release of Security Interest (this “Release”) is dated as of the date first set forth above. Reference is hereby made to that certain Trademark Security Agreement (Second Lien) (the “Trademark Security Agreement”; capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Security Agreement) dated as of May 31, 2011, by Securus Technologies, Inc., a Delaware corporation located at 14561 Dallas Parkway, Suite 600, Dallas, TX 75254 (“Securus”), and T-Netix, Inc., a Delaware corporation located at 14561 Dallas Parkway, Suite 600, Dallas, TX 75254 (“T-Netix” and together with Securus, collectively, the “Grantors”), in favor of BNP Paribas located at 787 Seventh Avenue, New York, NY 10019, in its capacity as collateral agent pursuant to the Second Lien Credit and Guaranty Agreement (in such capacity, the “Collateral Agent”), recorded with the United States Patent and Trademark Office on June 7, 2011, at Reel/Frame No. 4555/0332.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby notifies, acknowledges and agrees with each Grantor that (i) the lien on and security interest in the Trademark Collateral pledged and granted by such Grantor to the Collateral Agent, including, without limitation, the lien on and security interest in the trademarks listed on the attached Schedule A, is terminated, released and discharged fully, (ii) the Collateral Agent hereby terminates the Trademark Security Agreement, (iii) the Collateral Agent hereby releases and forever discharges fully all of its right, title and interest in, to and under, and of any kind or nature in the Trademark Collateral it may have been granted, assigned or conveyed pursuant to the Trademark Security Agreement, including all of the goodwill of the business associated with the use of and symbolized by the Trademark Collateral, all Proceeds of the foregoing, including royalties, income, payments, claims, damages, and proceeds of suit, and all tangible property used to make the goods associated with or depicting or displaying any of the Trademark Collateral, and (iv) any right, title or interest of the Collateral Agent in, to and under the Trademark Collateral shall hereby cease and become void. The Collateral Agent hereby retransfers and reassigns to each appropriate Grantor, without representation or warranty, all of the Collateral Agent’s right, title and interest it may have in, to and under the Trademark Collateral.

The Collateral Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
