RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (“**Release**”) granted on this 26th day of November, 2003, is delivered by **DEUTSCHE BANK TRUST COMPANY AMERICAS** (formerly known as Banker Trust Company) (“**Secured Party**”), as agent for the Lenders under that certain Security Agreement dated as of March 21, 2002 by and between **LOEWS CINEPLEX ENTERTAINMENT CORPORATION, CINEPLEX ODEON CORPORATION** (“**Grantor**”), the Subsidiary Grantors party thereto and Secured Party, as agent for the Lenders (the “**Agreement**”; capitalized terms used in this Release and not defined herein shall have the meanings assigned to such terms in the Agreement, whether by reference to another agreement or otherwise) to **GRANTOR**.

WHEREAS, in connection with the Agreement, Grantor assigned to Secured Party, and granted to Secured Party, a security interest in all of Grantor's rights, title and interest (including rights acquired pursuant to a license or otherwise) in and to all trademarks, service marks, designs, logos, indicia, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by Grantor, or hereafter adopted and used, in its business (including, without limitation, the trademarks specifically identified in Schedule A hereto) (collectively, the “**Trademarks**”), all registrations that have been or may hereafter be issued or applied for thereon in the United States and any state thereof, Canada and in foreign countries (including, without limitation, the registrations and applications specifically identified in Schedule A hereto) (the “**Trademark Registrations**”), all common law and other rights in and to the Trademarks in the United States and any state thereof, Canada and in foreign countries (the “**Trademark Rights**”), and all goodwill of such Grantor’s business symbolized by the Trademarks and associated therewith (the “**Associated Goodwill**”);

WHEREAS, Secured Party wishes to release and restore all right, title and interest in, to and under the Trademarks and Trademarks Registrations to Grantor and to dissolve any and all liens and encumbrances respecting the Trademarks and Trademark Registrations shown on the attached Schedule A hereto;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby releases, discharges, quit claims and relinquishes unto Grantor any and all right, title and interest in, to and under the Trademarks and Trademark Registrations set forth on Schedule A hereto granted to Secured Party by Grantor pursuant to the Agreement.


