RELEASE OF FIRST AMENDMENT TO  
TRADEMARK SECURITY AGREEMENT

FLOOR AND DECOR OUTLETS OF AMERICA, INC., a corporation organized and existing under the laws of the State of Delaware ("Grantor"), entered into a certain First Amendment to Trademark Security Agreement dated March 31, 2006 and recorded in the United States Patent and Trademark Office on April 5, 2006, at Reel 3283, Frame 0230 (the "Security Agreement"), whereby PNC BANK, National Association, a national association organized and existing under the laws of the United States ("Secured Party"), was granted a security interest in the trademark and federal registration listed on the attached Schedule A (the "Mark").
