pursuant to the Security Agreement dated as of the date hereof, by and among Innovation

Ventures, LLC (the "Company"), Innovation Ventures Finance Corp. (the "Co-Borrower" and,

together with the Company, the "Borrowers"), Assignor, each of the other guarantors from time

to time party thereto and Assignee (as the same may be amended, restated, modified,

supplemented and/or replaced from time to time, the "Security Agreement").

WHEREAS, Assignor is the owner of certain registered trademarks, trade names,

corporate names, company names, business names, fictitious business names, trade dress, service

marks, logos, designs, domain names and other source or business identifiers including, without

limitation, those listed on Exhibit 1 hereto, together with pending applications and/or

registrations therefor, all registrations and recordings thereof, whether in the United States Patent

and Trademark Office or in any similar office or agency of the United States or any State thereof,

or otherwise, all rights to obtain any reissues, renewals or extensions of the foregoing, all

common law rights related thereto, the goodwill associated therewith, all licenses for any of the

foregoing, and all causes of action arising prior to or after the date hereof for infringement,

dilution, misappropriation, violation and unfair competition of or regarding the same

(collectively, the "Marks"); and

WHEREAS, the Borrowers and Secured Party, entered into that certain Credit Agreement

dated as of the date hereof (as the same may be amended, restated, modified, supplemented

and/or replaced from time to time, the "Credit Agreement"), pursuant to which Borrowers are

issuing a \$25,000,000 Promissory Note (Line of Credit) payable to Secured Party (together with
