RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of May 31, 2013, by BANK OF AMERICA, N.A., a national banking association, with an office at 800 Market Street, 12th Floor, St. Louis, Missouri 63101-2510 ("Lender"), in favor of AMERICAN HEARTH SYSTEMS, INC., an Illinois corporation ("Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of January 30, 2009 made by Grantor in favor of Lender, Grantor granted a security interest in its entire right, title and interest in and to all of its trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, other business identifiers, prints and labels on which any of the foregoing have appeared or appear, all registrations and recordings thereof, and all applications (other than "intent to use" applications until a verified statement of use is filed with respect to such applications) in connection therewith, including, without limitation, the trademarks and applications listed on Schedule A attached hereto and made a part hereof and the trademarks, and renewals thereof, and all income, royalties, damages and payments due and/or payable under or with respect to any of the foregoing, including, without limitation, damages and payments for infringements of any of the foregoing and the right to sue for infringements of any of the foregoing, and all rights corresponding to any of the foregoing throughout the world and the goodwill of the Grantor's business connected with the use of and symbolized by the foregoing (all of the foregoing are collectively referred to herein as the "Trademarks") to Lender to secure certain debt and obligations owing from Grantor and certain other obligors to Lender;

WHEREAS, Grantor has requested that Lender (a) terminate and release the liens and interests of Lender in the Trademarks, and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office; and

WHEREAS, Lender has agreed to such release and termination;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) releases and terminates its security interests in and to the Trademarks, and (ii) reassigns to Grantor all right, title and interest of Lender in and to the Trademarks.

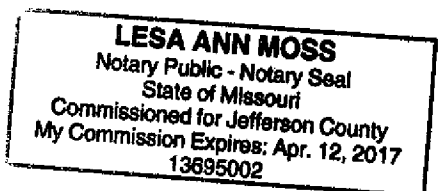
