TERMINATION OF SECURITY INTEREST
IN TRADEMARKS

This Termination of Security Interest, dated as of February 13, 2013, is made by Bank of America, N.A., as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of Warnaco Swimwear Inc. ("Grantor").

WHEREAS, pursuant to the Trademark Security Agreement ("Security Agreement"), dated as of August 30, 2011, between Grantor and the Collateral Agent, recorded with the United States Patent and Trademark Office on September 20, 2011, at Reel No. 4626 and Frame No. 0898, Grantor granted to the Collateral Agent a security interest in the "Trademark Collateral" (as defined in the Security Agreement), including without limitation the registrations and applications listed on Exhibit A hereto; and


WHEREAS, the Collateral Agent desires to release, discharge and terminate its security interest in all of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Collateral Agent hereby (1) releases, discharges and terminates its security interest in and lien on all of the Trademark Collateral, and (2) reassigns to Grantor, without representation, warranty or recourse, all right, title, and interest of the Collateral Agent in and to the Trademark Collateral. The Collateral Agent specifically acknowledges that the Security Agreement is no longer effective as to the Trademark Collateral, and that the Collateral Agent does not own any rights to or have any ownership interest or claim in any of the Trademark Collateral.
