**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Partial Release ("Release") is made this 18th day of June, 2013, by PNC Bank, National Association, as Administrative Agent (the "Secured Party"), in favor of Alco Industries, Inc., a Delaware corporation (the "Grantor").

**WHEREAS**, reference is made to the Security Agreement dated April 30, 2007 by Grantor in favor of Secured Party, recorded with the United States Patent and Trademark Office (the "USPTO") on May 18, 2007 at Reel/Frame 003546/0492, as amended by the First Amendment to the Security Agreement dated September 17, 2009 by Grantor in favor of Secured Party, recorded with the USPTO on September 18, 2009 at Reel/Frame 004064/0316, and the Second Amendment to Security Agreement dated February 28, 2011 by Grantor in favor of Secured Party, recorded with the USPTO on March 1, 2011 at Reel/Frame 004488/0198 (together, the "Security Agreement");

**WHEREAS**, pursuant to the terms and conditions of the Security Agreement, Grantor granted to Secured Party, a security interest in the trademarks set forth on Schedule A hereto together with all renewals and extensions thereof, the goodwill associated therewith, and all Proceeds (as defined in the Security Agreement) and products thereof (the "Trademark Collateral");

**WHEREAS**, Secured Party has the requisite power and authority to release and discharge its security interest in and to the Trademark Collateral; and

**WHEREAS**, Secured Party desires to release and discharge its security interest in and to the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Secured Party hereby releases all liens, security interests, encumbrances and interests of the Secured Party in and to the Trademark Collateral, and reassigns, without recourse or representation of any kind, any and all right, title and interest it may have in the Trademark Collateral to Grantor. The Secured Party hereby authorizes the Grantor or Grantor's authorized representative to record this Release with the USPTO.
