**TERMINATION AND RELEASE
OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (“**Termination and Release**”), dated as of June 11, 2013, is from **TD BANK, N.A.**, (formerly known as, TD Banknorth, N.A., “**TD Bank**”), to **MARK A. DUPUIS** (“**Guarantor**”).

WHEREAS, pursuant to the Security Agreement dated as of December 10, 2007 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “**Security Agreement**”) by Guarantor in favor of TD Bank and the Intellectual Property Security Agreement dated as of December 10, 2007 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “**Intellectual Property Security Agreement**”) by Guarantor in favor of TD Bank, a security interest was granted by the Guarantor to TD Bank (the “**Security Interest**”) in the Guarantor’s Domain Names, Trademarks, Patents and Copyrights (each as defined in the Security Agreement), including those listed on **Schedule A** attached hereto;

WHEREAS, the Intellectual Property Security Agreement was recorded as a document titled as a patent security agreement with the United States Patent and Trademark Office, at Reel 020251, Frame 0009 on December 14, 2007;

WHEREAS, the Intellectual Property Security Agreement was also recorded as a document titled as a trademark security interest with the United States Patent and Trademark Office, at Reel 003678, Frame 0661 on December 14, 2007; and

WHEREAS, TD Bank now desires to terminate and release the entirety of its Security Interest in the Domain Names, Trademarks, Patents and Copyrights;

NOW, THEREFORE, for good and valuable consideration, including the full payment, performance, and satisfaction of all indebtedness, obligations, and liabilities secured by the Domain Names, Trademarks, Patents and Copyrights pursuant to the Security Agreement and the Intellectual Property Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, TD Bank hereby states as follows:

1. **Definitions**. Capitalized terms used but not specifically defined herein shall have the meanings given to them in the Security Agreement and the Intellectual Property Security Agreement.
2. **Termination and Release of Security Interest**. TD Bank hereby terminates, releases, and discharges the entirety of its Security Interest in the Domain Names, Trademarks, Patents and Copyrights, including those listed on **Schedule A** attached hereto. Any and all right, title, or interest of TD Bank in such Domain Names, Trademarks, Patents and Copyrights, and all proceeds thereof, including without limitation, the goodwill of the business connected with the

use of, and symbolized by, the Domain Names, Trademarks, Patents and Copyrights, and any and all causes of action which may exist by reason of infringement thereof, shall hereby cease and become void.

3. Further Assurances. TD Bank hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the Security Interest in the Domain Names, Trademarks, Patents and Copyrights contemplated hereby.

4. Counterparts. This Termination and Release may be executed in any number of counterparts which shall together constitute one and the same agreement.
