**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 17 2013 ("Release"), is made by Bank of America, N.A., as Bank ("Bank") in favor of E1 LLC, a North Carolina limited liability company ("Grantor").

**WHEREAS**, pursuant to that certain Security Agreement dated as of April 15, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Pledgors party thereto and the Bank, each Pledgor granted to the Bank a security interest in all the trademarks, service marks, and trade names, and goodwill connected with or symbolized with the foregoing ("Trademark Collateral") of such Pledgor;

**WHEREAS**, pursuant to the Security Agreement, Grantor, a Pledgor, executed and delivered to Bank the Notice of Grant of Security Interest in Trademarks dated as of April 15, 2013 and recorded at the United States Patent and Trademark Office ("USPTO") on April 16, 2013 at Reel 5007 Frame 0738 ("Notice"); and

**WHEREAS**, the Grantor and Bank have determined that the security interest granted by Grantor in certain Trademarks identified on Schedule A attached hereto was granted in error.

**NOW THEREFORE**, to correct the error, Bank and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

**SECTION 2. Termination and Release.** Bank, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Trademark Collateral listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the governing law set forth in the Security Agreement.

**SECTION 4. Acknowledgement.** The release of security interest granted herein expressly does not include a release of the security interest granted in the Trademark Collateral not listed on Schedule A.

**IN WITNESS WHEREOF**, the Bank has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
