**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 28, 2013 ("Release"), is made by **BANK OF AMERICA, N.A.** ("Lender") in favor of **CENTURY FURNITURE, LLC**, a North Carolina limited liability company ("Borrower").

**WHEREAS**, pursuant to that certain Loan and Security Agreement dated as of May 28, 2008 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Borrowers party thereto and the Lender, each Borrower granted to the Lender a continuing security interest in and continuing lien upon any and all right, title and interest of such Borrower in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing;

**WHEREAS**, pursuant to the Security Agreement, Borrower executed and delivered to Lender the Notice of Grant of Security Interest in Trademarks dated as of May 28, 2008 ("Notice"); and

**WHEREAS**, the Notice was recorded at the United States Patent and Trademark Office ("USPTO") on June 3, 2008 at Reel 3787 Frame 0571.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender and Borrower agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

**SECTION 2. Termination and Release.** Lender without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest of Borrower in, to, and under the Trademarks, Trademark Licenses, and Proceeds of the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Borrower's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of North Carolina.

**SECTION 4. Acknowledgement.** The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Loan and Security Agreement dated as May 28, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time) by and among the Borrowers party thereto (as defined therein) and Bank of America, N.A.
