INTELLECTUAL PROPERTY LICENSE AGREEMENT

THIS INTELLECTUAL PROPERTY LICENSE AGREEMENT ("Agreement") is entered into as of June 28, 2013 ("Effective Date"), by and among WELLS FARGO BANK, NATIONAL ASSOCIATION, acting in its capacity as administrative agent on behalf of the Lenders (the "Administrative Agent"), UNIFIED GROCERS, INC., a California corporation ("Borrower"), and each of the undersigned direct and indirect Material Subsidiaries of Borrower (together with Borrower, the "Obligors"), with reference to the following:

WHEREAS, the Administrative Agent and the Borrower are parties to a certain Amended and Restated Credit Agreement dated as of June 28, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"; all capitalized terms not defined herein shall have the meanings set forth in the Credit Agreement);

WHEREAS, the Administrative Agent and the Obligors are parties to a certain Amended and Restated Security Agreement, dated as of June 28, 2013;

WHEREAS, the Obligors are the owners of certain intellectual property and other proprietary rights, including all rights arising in connection with copyrights, patents, service marks, trade dress, trade secrets, trademarks, trade names or mask works, including the intellectual property set forth on Schedule 1 attached hereto (the "Licensed Intellectual Property");

WHEREAS, upon the occurrence and during the continuation of an Event of Default, as set forth in the Loan Documents, the Obligors and the Administrative Agent have agreed that the Administrative Agent may use any of the Licensed Intellectual Property as set forth below; and

WHEREAS, the Obligors wish to grant the Administrative Agent rights to use the Licensed Intellectual Property and the Administrative Agent desires to acquire such rights.

NOW THEREFORE, in consideration of the premises and the mutual promises set forth below, the parties agree as follows:

1. License Grant.

(a) Subject to the terms of this Agreement and the Security Agreement, each Obligor, effective upon the occurrence and during the continuance of an Event of Default, hereby grants to Administrative Agent an irrevocable, nonexclusive, royalty-free and rent-free right and license to use all trademarks, trade names and copyrights owned or used by such Obligor that relate to the Inventory, all solely to the extent necessary to enable Administrative Agent to realize on the Inventory in connection with the exercise of remedies in accordance with this Agreement and to enable any transferee or assignee of Administrative Agent as a result of such exercise of remedies to enjoy the benefits of the Inventory (the "Administrative Agent License"). This right shall inure to the benefit of all successors, assigns and transferees of Administrative Agent and to their successors,

assigns and transferees, whether by voluntary conveyance, operation of law, assignment, transfer foreclosure, deed in lieu of foreclosure or otherwise. Such right and license shall be granted free of charge, without requirement that any monetary payment whatsoever be made to such Obligor.

(b) Except for the Administrative Agent License granted to Administrative Agent pursuant to this Agreement, Obligors reserve all right, title and interest in and to the Licensed Intellectual Property.

2. Ownership. The Administrative Agent acknowledges the ownership of the Intellectual Property by the Obligors, and the Administrative Agent agrees that it will do nothing inconsistent with such ownership. The parties agree to cooperate in recordation of this Agreement with appropriate government authorities if necessary.

3. Term. The term of this Agreement will commence on the Effective Date and continue until the Obligations have been paid in full and the Commitments shall have terminated.

4. Miscellaneous.

(a) This Agreement does not in any way create the relationship of principal and agent, franchise, joint venture, or partnership. Neither party will act or attempt to act, or represent itself to others, as an agent of the other party or in any manner assume or create any obligation on behalf of or in the name of the other party, pursuant to this Agreement. Neither party will be liable for any debts or obligations of the other unless expressly assumed in writing.

(b) All rights and remedies conferred hereunder and by law will be cumulative.

(c) No waiver of a default by either party will be construed as a waiver of any other provision, performance, or default.

(d) If any provision is held to be unenforceable, the balance of this Agreement will continue in full force and effect; provided however that if the provision so held to be invalid or unenforceable granted to either party a material and fundamental right, then such party may elect to terminate this Agreement immediately.

(e) This Agreement constitutes the entire agreement of the parties with respect to the subject matter hereof, superseding all prior or contemporaneous written or oral agreements.

(f) This Agreement will be binding upon and will inure to the benefit of the parties hereto and their respective heirs, successors and permitted assigns.

(g) This Agreement, including all matters relating to the validity, construction, performance, and enforcement thereof, will be governed by the laws of the State of


California without regard to its conflicts of law rules, and all disputes will be resolved in courts located in the State of California, to whose jurisdiction the parties hereby consent.
