**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of July 19, 2013, is made by Ableco Finance LLC, as collateral agent (in such capacity, the "Collateral Agent"). Capitalized terms not otherwise defined herein shall have the meanings given to them in the Security Agreement (as defined below).

**WHEREAS**, reference is made to that certain Security Agreement dated as of November 1, 2004 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), made by the Debtors in favor of the Collateral Agent for the benefit of the Agents and Lenders;

**WHEREAS**, in connection with the Security Agreement, Miller's Ale House, Inc. (the "Borrower") and the Collateral Agent entered into that certain Trademark Security Agreement, dated as of November 1, 2004 (the "Borrower Trademark Security Agreement"), in which the Borrower granted a security interest in all of its right, title and interest in and to the Trademark Collateral (as defined in the Borrower Trademark Security Agreement, the "Borrower Trademark Collateral") including those trademarks and trademark applications owned or held by the Borrower listed on Schedule A attached hereto (the "Borrower Trademarks");

**WHEREAS**, in connection with the Security Agreement, Ale House Holdings, Inc. (the "Parent", together with the Borrower, the "Debtors") and the Collateral Agent entered into that certain Trademark Security Agreement, dated as of November 1, 2004 (the "Parent Trademark Security Agreement", together with the Borrower Trademark Security Agreement, the "Trademark Security Agreements"), in which the Parent granted a security interest in all of the Parent's right, title and interest in and to the Trademark Collateral (as defined in the Parent Trademark Security Agreement, the "Parent Trademark Collateral", together with the Borrower Trademark Collateral, the "Trademark Collateral") including those trademarks and trademark applications owned or held by the Parent listed on Schedule B attached hereto (the "Parent Trademarks", together with the Borrower Trademarks, the "Trademarks"); and

**WHEREAS**, the Borrower Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on November 8, 2004 at Reel 3073 / Frame No. 0282.


**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent on behalf of itself and the Agents and Lenders hereby terminates the Trademark Security Agreements and releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its security interest in the Trademark Collateral including the Trademarks, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Trademark Collateral including the Trademarks, to the Debtors, as applicable.

The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereunder and any claim or controversy relating hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York, without regard to its conflicts of laws principles.
