GRANT OF
SECURITY INTEREST IN TRADEMARK

This GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (“**Agreement**”), effective as of July 31, 2013 is made by (i) The Reader's Digest Association, Inc., a Delaware corporation, located at 44 South Broadway, White Plains, NY 10601; (ii) Reiman Media Group, LLC, a Delaware limited liability company, located at 5400 South 60th Street, Greendale, Wisconsin 53129; (iii) Reader’s Digest Sales and Services, Inc., located at 44 South Broadway, White Plains, New York, 10601 and (iv) World Almanac Education Group, Inc., a Delaware corporation, located at 44 South Broadway, White Plains, NY 10601 (each a “**Grantor**”), in favor of Wilmington Trust, National Association, a national banking association, located at 50 South Sixth Street, Suite 1290, Minneapolis MN 55402, Attention: Jeffrey Rose, as Collateral Agent (the “**Agent**”) for the Secured Parties (as defined in the Security Agreement).

W I T N E S S E T H:

WHEREAS, Holdings, the Borrower and certain subsidiaries of the Borrower have entered into the Credit and Guarantee Agreement, dated as of July 31, 2013 with Wells Fargo Bank, National Association, as First Out Administrative Agent (as it may hereafter be amended, amended and restated, supplemented, waived or otherwise modified from time to time pursuant to the terms thereof and of the Second Out Exit Credit Agreement, the “**First Out Exit Credit Agreement**”);

WHEREAS, pursuant to the First Out Exit Credit Agreement, the Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, Holdings, the Borrower and certain subsidiaries of the Borrower have entered into the Credit and Guarantee Agreement, dated as of July 31, 2013 with Wilmington Trust, National Association, as Second Out Administrative Agent (as it may hereafter be amended, amended and restated, supplemented, waived or otherwise modified from time to time pursuant to the terms thereof and of the First Out Exit Credit Agreement, the “**Second Out Exit Credit Agreement**”);

WHEREAS, in connection with the First Out Exit Credit Agreement and the Second Out Exit Credit Agreement, the Grantor has executed and delivered a Security Agreement, dated as of July 31, 2013 of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “**Security Agreement**”);

WHEREAS, pursuant to the Security Agreement, the Grantor pledged and granted to the Agent for the benefit of the Secured Parties a continuing security interest in all Intellectual Property, including the Trademarks of such Grantor; and

WHEREAS, the Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Grantor agrees, for the benefit of the Secured Parties, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement.

SECTION 2. Grant of Security Interest. The Grantor hereby pledges and grants to the Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Grantor's right, title and interest in the Trademarks of such Grantor (including, without limitation, those items listed on Schedule A hereto) (collectively, the "**Collateral**"); provided, however, that this Agreement shall not constitute a grant of a security interest in any property to the extent that such grant of a security interest is (i) prohibited by any Requirements of Law of a Governmental Authority, requires a consent not obtained of any Governmental Authority pursuant to such Requirement of Law or is prohibited by, or constitutes a breach or default under or results in the termination of or requires any consent not obtained under, any contract, license, agreement, instrument or other document evidencing or giving rise to such property, except to the extent that such Requirement of Law or the terms in such contract, license, agreement, instrument or other document providing for such prohibition, breach, default or termination or requiring such consent is ineffective under applicable law, or (ii) the grant of a security interest would result in the invalidity, unenforceability, voiding or cancellation of any Collateral (including, without limitation, any Trademark application filed on an intent to use basis).

SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Trademark Office. The security interest granted hereby has been granted to the Secured Parties in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The Security Agreement (and all rights and remedies of the Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Parties with respect to the security interest in the Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.




