**FIRST SUPPLEMENT TO GRANT OF SECURITY INTEREST IN UNITED STATES  
TRADEMARKS**

THIS FIRST SUPPLEMENT TO GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (the "Supplement"), is dated as of July 3, 2013, and entered into by and among Tekni-Plex, Inc., a Delaware corporation, (the "Company"), TP/ELM Acquisition Subsidiary, Inc., a Delaware corporation, Natvar Holdings, LLC, a Delaware limited liability company formerly known as Natvar Holdings, Inc., Tri-Seal Holdings, Inc., a Delaware corporation, Tri-Acquisition Subsidiary, Inc., a Delaware corporation, PureTec Corporation, a Delaware corporation, Burlington Resins, Inc., a Delaware corporation, Plastic Specialties and Technologies, Inc., a Delaware corporation and Plastic Specialties and Technologies Investments, Inc., a Delaware corporation (together with the Company, each a "Grantor" and collectively, the "Grantors") and BANK OF AMERICA, N.A., as Agent (in such capacity together with its successors and assigns in such capacity, "Grantee").

RECITALS

A. Grantors, the other Borrowers from time to time party thereto, the lenders party thereto, and Grantee are parties to that certain First-Lien Loan and Security Agreement dated November 19, 2010 (as amended, modified, supplemented or restated from time to time, the "Loan Agreement"). Capitalized terms used herein have the meanings given to them in the Loan Agreement unless otherwise specified.

B. To induce Grantee to provide the financial accommodations described in the Loan Agreement, Grantors and Grantee entered into that certain Grant of Security Interest In United States Trademarks (as recorded on March 30, 2011 with the United States Patent and Trademark Office at REEL/FRAME 004518/0662 and as amended, modified, supplemented or restated from time to time, the "Agreement").

C. Grantors have requested that Grantee modify and supplement certain terms of the Agreement as set forth herein.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements herein contained, it is agreed as follows:

1. Supplements to the Agreement. Schedule A to the Agreement is hereby supplemented by adding the United States trademarks, trademark registrations, trademark applications and domain names set forth on Schedule A hereto ("New Marks"), in each case, including the New Marks as Marks (as defined in the Agreement) thereunder.

2. No Other Changes. Except as modified by this Supplement, all of the terms and conditions of the Agreement and the Loan Agreement shall remain in full force and effect are hereby ratified and reaffirmed by Grantors.


