NOTICE OF GRANT OF A SECURITY INTEREST IN TRADEMARKS (this "Notice")

July 29, 2013

WHEREAS, each of Highwinds Newtwork Group, Inc. ("HNG"), Easynews Holdings, Inc. ("ENH"), UNS Holdings, Inc. ("UNS"), and Bandwidth Consulting, Inc. ("BWC"), and together with HNG, ENH, and UNS, each a "Grantor" and collectively, the "Grantors") has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed opposite its name on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, each Grantor has entered into a Pledge and Security Agreement, dated July 29, 2013 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of Cerberus Business Finance, LLC, as the collateral agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Agent");

WHEREAS, pursuant to the Security Agreement, each Grantor has assigned to the Assignee and granted to the Agent for the benefit of the Secured Parties (as defined in the Security Agreement) a continuing security interest in all right, title and interest of such Grantor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement); and


WHEREAS, pursuant to the Security Agreement, each Grantor has agreed to the filing of this Notice with the United States Patent and Trademark Office to evidence the Agent's continuing security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby authorizes the filing of this Notice with the United States Patent and Trademark Office to evidence the Agent's continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.


Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

IN WITNESS WHEREOF, each Grantor has caused this Notice to be duly executed by its officer thereunto duly authorized as of the date first set forth above.




