RELEASE OF SECURITY INTEREST  
IN IP COLLATERAL  
(United States)

OVERHILL FARMS, INC., a Nevada corporation ("Grantor"), whose address is 2727 E. Vernon Ave., Vernon, CA 90058, executed a Borrower Security Agreement dated as of September 24, 2010, in favor of BANK OF AMERICA, N.A., as Administrative Agent ("Agent"), whose address is 333 S. Hope St., 13<sup>th</sup> Floor, Los Angeles, CA 90071 (as amended from time to time, the "Agreement"), which Agreement was duly recorded on September 27, 2010, at Trademark Reel/Frame 4284/0686 in the United States Patent and Trademark Office (the "USPTO"), and pursuant to which the Grantor granted to Agent, for the benefit of certain secured parties, a security interest in and to all of Grantor's right, title and interest in and to the IP Collateral (as defined in the Agreement), including those trademarks and/or trademark applications listed on Exhibit A attached hereto (and the goodwill associated therewith) and those license agreements listed on Exhibit B attached hereto.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent hereby releases and discharges fully its security interest in and to the IP Collateral, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Agent, all of Agent's right, title and interest in and to the IP Collateral, the goodwill associated therewith, and all causes of action for past infringement, if any. Agent hereby authorizes and requests that the USPTO record this Release of Security Interest in IP Collateral (this "Release"), and Agent hereby authorizes Grantor to file this Release on behalf of Agent with the USPTO. At Grantor's sole cost and expense, Agent shall take such further actions, and provide to Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), as are reasonably requested by Grantor to release, as of record, the security interest of the Agent in the IP Collateral.


