**NOTICE OF GRANT OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

THIS NOTICE OF GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Notice"), is made effective as of the 8th day of August, 2013, by and from ROLLEASE, INC., a Delaware corporation (the "Debtor"), to and in favor of RBS CITIZENS, N.A., a national banking association (the "Secured Party").

WHEREAS, this Notice is being executed contemporaneously with (i) a Commercial Loan Agreement of even date herewith between ROLLEASE ACQUISITION COMPANY, INC., (the "Initial Borrower"; prior to, and after, the consummation of the Acquisition, Initial Borrower shall be referred to as the "Borrower"), and immediately after the consummation of the Acquisition each of ROLLEASE HOLDINGS, INC., ("Holdings") and Debtor (together with Holdings, each, an "Additional Borrower" and together with the Initial Borrower, individually and collectively, the "Borrower") and the Secured Party (the "Loan Agreement"; capitalized terms note defined herein shall have the meanings given to them in the Loan Agreement) whereby the Secured Party has extended to the Borrower certain credit facilities consisting of a Revolving Line of Credit Loan and a Term Loan (collectively, the "Loans"), all as set forth and described in the Loan Agreement, and (ii) a Master Security Agreement of even date between the Secured Party and the Debtor (the "Security Agreement") whereby the Debtor has granted to the Secured Party a Lien on the Debtor's right, title and interest in and to its inventory, accounts, goods, equipment, machinery, general intangibles and other assets referred to therein relating to goods and services manufactured, sold, licensed and marketed under the Intellectual Property Collateral to secure the Loans from the Secured Party to the Borrower.

WHEREAS, the Debtor owns the patents (the "Patents") listed on Exhibit A attached hereto, which Patents are pending or issued with the United States Patent and Trademark Office ("USPTO"); the trademarks (the "Trademarks") listed on Exhibit B attached hereto, which Trademarks are pending or registered with the USPTO; and the copyrights (the "Copyrights") listed on Exhibit C attached hereto, which Copyrights are pending or registered with the United States Copyright Office (collectively the "Intellectual Property Collateral");

WHEREAS, the intent and purpose of this Notice is to confirm the security interest arising under and pursuant to the terms of the Loan Agreement and the Security Agreement. The rights and remedies of the Secured Party with respect to the security interest confirmed herein are without prejudice to and are in addition to those set forth in the Security Agreement and the other Loan Documents, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Notice are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Security Interest.

(a) This Notice is given to secure the satisfactory performance and payment of all the Secured Obligations. Upon the payment in full of all Secured Obligations (other than contingent indemnification obligations), the Secured Party shall promptly, upon such satisfaction, execute, acknowledge, and deliver to Debtor all reasonably requested instruments in writing releasing the security interest in the Intellectual Property Collateral acquired under this Notice.

(b) The Debtor hereby confirms the grant of security interest to the Security Party in (1) all of Debtor's right, title and interest in and to the Intellectual Property Collateral set forth in Exhibits A-C now owned or from time to time after the date hereof owned or acquired by the Debtor, together with (2) all proceeds and products of the Intellectual Property Collateral, (3) the goodwill associated with the Trademarks, and (4) all causes of action arising prior to or after the date hereof for infringement of the Intellectual Property Collateral or unfair competition regarding the same.

2. General Provisions.

(a) Definitions. Unless otherwise defined herein, terms used herein shall have the meanings set forth in the Security Agreement or in the Loan Agreement.

(b) Counterparts. This Agreement may be executed in as many counterparts as may be deemed necessary and convenient, and by the different parties hereto on separate counterparts, each of which when so executed shall be deemed an original, but all such counterparts shall constitute one and the same instrument.

(c) Headings. The headings to Sections appearing in this Agreement and in any Loan Document have been inserted for the purpose of convenience and ready reference. They do not purport to, and shall not be deemed to, define, limit or extend the scope or intent of the Sections to which they appertain.


(d) Loan Document. This Agreement shall constitute a "Loan Document" as defined in the Loan Agreement. The terms and provisions of this Agreement are intended to supplement the terms and provisions of the security portions of the Security Agreement and are not intended to limit the force or effect of such provisions.




