DISCHARGE OF RECORDED SECURITY INTEREST IN TRADEMARK

WHEREAS, by a Collateral Assignment (Trademarks) dated December 6, 2010 (the "Security Agreement"), THE DOLAN COMPANY (f/k/a Dolan Media Company) ("Dolan") granted a security interest in the United States trademarks listed in Exhibit A attached hereto and in the other collateral described in the Security Agreement (collectively, the "Collateral") to U.S. BANK NATIONAL ASSOCIATION, AS ADMINISTRATIVE AGENT for the lenders (the "Lenders") from time to time party to the Credit Agreement defined in the Security Agreement (in such capacity, and together with any successor in such capacity, the "Agent"), in order to secure repayment of certain amounts then owing to the Lenders.

WHEREAS, the marks listed in Exhibit A do not include all of the marks secured by the Security Agreement, and therefore the Security Agreement will remain effective for such marks not included in Exhibit A.

NOW THEREFORE, to all who it may concern be it known that the Agent hereby (a) releases and discharges all the security interests in the marks listed in Exhibit A that were granted by the Security Agreement, and (b) acknowledges, confirms and agrees that the Security Agreement is discharged, released and terminated and of no further force or effect with respect to the marks listed in Exhibit A only.
