## SECURITY INTEREST IN TRADEMARKS

This **SECURITY INTEREST IN TRADEMARKS** ("Agreement") is made as of August 14, 2013 by **WHITE CASTLE MANAGEMENT CO.**, a Delaware corporation, having an office at 555 West Goodale Street, Columbus, Ohio 43216-1498 (the "Grantor") in favor of **JPMORGAN CHASE BANK, N.A.**, a national banking association, having an office at 100 East Broad Street, 10th Floor, OH 1-0170, Columbus, OH 43215, in its capacity as collateral agent (the "Collateral Agent") for the Creditors, as defined in the Intercreditor and Collateral Agency Agreement, dated as of the date hereof, among the Administrative Agent, the Collateral Agent, and The Prudential Insurance Company of America.

WHEREAS, the Grantor entered into that certain Credit Agreement dated as of date hereof (as from time to time, amended, modified, or supplemented, the "Credit Agreement") (all capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement), between the Grantor, the Collateral Agent, the other Loan Parties and the Lenders, pursuant to which the Lenders made certain financial accommodations available to the Borrowers;

WHEREAS, the Borrowers entered into that certain Note Agreement dated as of date hereof (as from time to time, amended, modified, or supplemented, the "Note Agreement"), between the Borrowers and purchasers named on the Purchaser Schedule attached thereto (the "Purchasers"), pursuant to which the Purchasers made certain financial accommodations available to the Borrowers;

WHEREAS, to secure the performance of the Borrowers' obligations under the Credit Agreement and the Note Agreement, the Grantor entered into that certain Pledge and Security Agreement dated as of the date hereof, by which the Grantor granted to the Collateral Agent, for the benefit of the Creditors, a security interest in and to all trademarks, trademark registrations and applications and the goodwill symbolized thereby currently owned by the Grantor or acquired by the Grantor after such date; and

WHEREAS, the Grantor is the owner of the trademarks, trademark registrations, and trademark applications listed on Exhibit A, and the goodwill symbolized thereby, and the parties wish to document the security interest granted to the Collateral Agent, for the benefit of the Creditors, with respect thereto;










