**TRADEMARK RELEASE**

This Release is granted as of August 13, 2013, by DEUTSCHE BANK TRUST COMPANY AMERICAS, as Collateral Agent, with principal offices at 60 Wall Street, New York, New York 10005 (the "Grantee") to Ameristar Casinos, Inc., a Nevada corporation with its chief executive office at 3773 Howard Hughes Parkway, Suite 490S, Las Vegas, Nevada 89169 (the "Grantor"), as follows:


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantee hereby, without recourse and without representation or warranty of any kind (either express or implied), releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in, to and under the Marks, and more particularly, (i) the continuing security interest in the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the business symbolized by the Marks and (iv) all causes of action prior to or after April 14, 2011 for infringement of any of the Marks or unfair competition regarding the same, and granted to the Grantee by the Grantor by the Security Agreement which was duly recorded on April 15, 2011 at Trademark Reel 4522, Frame 0827 in the United States Patent and Trademark Office.
