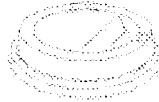

The undersigned declares as follows:

STATEMENTS: The undersigned has firsthand knowledge of the facts and is properly authorized to execute this declaration on behalf of the registrant; he/she believes and confirms that the owner of the above-identified Trademark Registration, as per the Merger recorded with the United States Patent and Trademark Office on December 13, 2005 under Reel/Frame No. 3209/0286, is Solo Cup Operating Corporation, a corporation organized under the laws of Delaware.

The current owner of the Trademark Registration is identified erroneously in the USPTO records as Solo Cup Company LLC. The proper owner of the subject Registration has been and continues to be Solo Cup Operating Corporation. The error in the USPTO records occurred when a Change of Name document from Solo Cup Company to Solo Cup Company LLC was

submitted by mistake to the USPTO and recorded for the subject Registration on January 3, 2013 under Reel/Frame No. 4934/0896. At the time the Change of Name was submitted, it was erroneously believed that the registration was owned by Solo Cup Company due to the failure of the USPTO to update its TESS records when the merger making Solo Cup Operating Corporation owner was recorded on December 13, 2005. The merger document was recorded, but the change was not apparent in the TESS records, so it looked like Solo Cup Company was the owner of the registration instead of Solo Cup Operating Corporation. Because there had been a change of name for Solo Cup Company, the Change of Name document at issue here was recorded. However, in fact, the chain of title for the subject Registration shows that Solo Cup Operating Corporation was the owner of the mark at time the erroneous change of name from Solo Cup Company to Solo Cup Company LLC was recorded and there has been no change of ownership from Solo Cup Operating Corporation to either Solo Cup Company or Solo Cup Company LLC. Thus, as required by TMEP 503.06(c), I herewith confirm that Solo Cup Operating Corporation has been and continues to be the owner of the registration, and the Change of Name recorded under Reel/Frame 4934/0896 was inadvertently submitted and recorded in error. This Declaration is submitted in order to correct the records in the chain of title for the above-identified registration.
