RELEASE OF GRANT OF A SECURITY INTEREST IN TRADEMARKS

WHEREAS, Releasees have requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Releasor's security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
2. Release of Security Interest. Releasor hereby, without any representation and warranty, releases, relinquishes and discharges its security interest in the Collateral.
