## **QUITCLAIM ASSIGNMENT OF TRADEMARK RIGHTS AGREEMENT**

This QUITCLAIM ASSIGNMENT OF TRADEMARK RIGHTS AGREEMENT ("Agreement") is made and entered into as of August 26, 2013, by and between The Huntington National Bank ("Huntington Bank") and Hartzell Propeller Inc., an Ohio corporation with a place of business at One Propeller Place, Piqua, Ohio 45356 ("Hartzell").

WHEREAS, Huntington Bank and Hartzell, are parties to that certain Assignment Agreement, dated April 9, 1987 (the "Assignment Agreement"); and

WHEREAS, in connection with the securing of a loan (the "Loan") made to Hartzell by Huntington Bank, the Assignment Agreement purported to assign all right, title and interest in certain patents, patent applications, trademarks and trade names (the "Assigned Property") from Hartzell to Huntington Bank;

WHEREAS, certain trade names and trademarks, including United States Trademark Registration No. 981,535 for HARTZELL and United Kingdom Trademark Registration No. B653190 for HARTZELL & DESIGN (the "Hartzell Trademarks") were included in the Assigned Property;

WHEREAS, Hartzell has represented to Huntington Bank that Hartzell has continued to use the Hartzell Trademarks in commerce since April 9, 1987; and

NOW, THEREFORE, for good and valuable consideration, including the previous repayment of the Loan, the receipt and sufficiency of which is hereby acknowledged, Huntington Bank hereby assigns, transfers, grants, conveys and relinquishes to Hartzell, its successors, assigns or other legal representatives, any and all right, title and interest of Huntington Bank, if any, in and to the Assigned Property, including the Hartzell Trademarks (which are further detailed on the attached Schedule A); all registrations, and applications for registration of the Hartzell Trademarks worldwide; all income, royalties, damages and payments now or hereafter due or payable with respect to the Hartzell Trademarks worldwide; all rights of action arising from the Hartzell Trademarks worldwide, including all claims for damages by reason of past,

present and future infringement of the Hartzell Trademarks and the right to sue and collect damages for such infringement, to be held and enjoyed by Hartzell for its own use and benefit and for its successors and assigns as the same would have been held by Huntington Bank had this Agreement not been executed; and the goodwill of the business symbolized by the Hartzell Trademarks.

Huntington Bank covenants and agrees that it will, at any time upon written request by Hartzell, do everything reasonable to aid Hartzell, its successors, assigns or other legal representatives, to document, effectuate or protect the rights assigned herein, all without further consideration but at the expense of Hartzell, its successors, assigns or other legal representatives.

In witness whereof, The Huntington National Bank has executed this Assignment as of this 26 day of August, 2013.

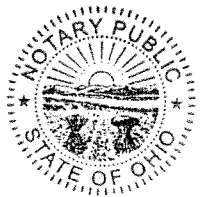
