THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Agreement") made as of this 3rd day of September, 2013 by TENON LIMITED, a New Zealand limited company ("Tenon Limited"), TENON MANUFACTURING LIMITED, a New Zealand limited company ("Tenon Manufacturing"), ORNAMENTAL PRODUCTS, LLC, a North Carolina limited liability company ("Ornamental Products"), ORNAMENTAL MOULDINGS, LLC, a Delaware limited liability company ("Ornamental Mouldings"), THE EMPIRE COMPANY, LLC, a Michigan limited liability company ("The Empire Company"), and ORNAMENTAL MOULDINGS COMPANY, a Nova Scotia unlimited liability company ("Ornamental Mouldings Company", and together with Tenon Limited, Ornamental Products, Ornamental Mouldings and The Empire Company, collectively, the "Grantor") in favor of PNC BANK, NATIONAL ASSOCIATION, in its capacity as Agent ("Agent"), for the financial institutions (collectively, the "Lenders") which are now or which hereafter become a party to the Loan Agreement (as defined below):

### WITNESSETH

WHEREAS, Grantors, TENON INDUSTRIES LIMITED, a New Zealand limited company, FLETCHER WOOD SOLUTIONS, INC., a Delaware corporation, COMANCHE INVESTMENTS, LLC, a Delaware limited liability company, FAIRFIELD ROAD, LLC, a North Carolina limited liability company, ORNAMENTAL MOULDINGS, LLC, a Delaware limited liability company, SOUTHWEST MOULDING CREATIVE WOOD PRODUCTS, LP, a Texas limited partnership, CREATIVE STAIR PARTS, LLC, a Michigan limited liability company, SOUTHWEST MOULDING CO., LP, a Texas limited partnership, SOUTHWEST MOULDING TRUCKING CO., LP, a Texas limited partnership, TENON SUPPLY LLC, a North Carolina limited liability company, and THE EMPIRE CANADA COMPANY LTD., an Ontario corporation (collectively, the "Borrowers", and each a "Borrower"), Lenders and Agent are parties to a certain Revolving Credit, Term Loan and Security Agreement of even date herewith (as same may be amended, restated, supplemented or modified from time to time, the "Loan Agreement") providing for the extensions of credit to be made to Borrowers by Lenders;

WHEREAS, Grantor has granted to Agent, for the benefit of Lenders, a security interest in substantially all of the assets of Grantor including all right, title and interest of Grantor in, to and under all now owned and hereafter acquired trademarks, copyrights, and patents, together with the goodwill of the business symbolized by Grantor's trademarks, patents and copyrights and all products and proceeds thereof, to secure the payment of all amounts owing by Borrowers (including Grantor) under the Loan Agreement;

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantor agrees as follows:

1. <u>Incorporation of Loan Agreement</u>. The Loan Agreement and the terms and provisions thereof are hereby incorporated in their entirety by this reference. All terms capitalized

but not otherwise defined herein shall have the same meanings ascribed to them in the Loan Agreement.

- 2. <u>Grant of Security Interests</u>. To secure the payment and performance of the Obligations, Grantor hereby grants to Agent, for its benefit and the benefit of Lenders, a continuing security interest in Grantor's entire right, title and interest in and to the following whether now owned or existing or hereafter created, acquired or arising:
  - (i) each trademark, patent and copyright listed on <u>Schedule 1</u> annexed hereto, (such trademarks, patents and copyrights, the "<u>Trademarks</u>", "<u>Patents</u>" and "<u>Copyrights</u>") together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark and Copyright; and
  - (ii) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any trademark or patent, or (b) injury to the goodwill associated with any trademark.

provided, that notwithstanding the foregoing, the terms "Trademarks", "Patents", and "Copyrights" shall not include any Excluded Property.

- 3. <u>Representations and Warranties</u>. Grantor hereby represents and warrants that the Trademarks, Patents and Copyrights listed on <u>Schedule I</u> attached hereto constitute all trademarks, patents and copyrights owned or registered to Grantor that are material to the Borrowers' business.
- 4. <u>PPSA Waivers</u>. Tenon Limited and Tenon Manufacturing waive their rights to receive any verification statement in respect of any financing statement or financing change statement relating to any security interest created under this Agreement. The parties also agree that, to the extent permitted by law and in respect of this Agreement and the security interest created under it, Tenon Limited, Tenon Manufacturing, and the Agent contract out of sections 114(1)(a), 133 and 134 of the Personal Property Securities Act 1999 (NZ) (the "<u>PPSA</u>") and Tenon Limited and Tenon Manufacturing waive their rights to receive notice of the Agent's right to retain personal property under section 120 of the PPSA and to object to the Agent's proposal to retain any personal property under Section 121 of the PPSA.
- 5. Applicable Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York applied to contracts to be formed wholly within the State of New York; however, insofar as this Agreement relates to companies incorporated in New Zealand, this Agreement shall be governed by New Zealand law. Any judicial proceeding brought by or against any Grantor with respect to this Agreement or any related agreement may be brought in any court of competent jurisdiction in the State of New York, United States of America, and, by execution and delivery of this Agreement, Grantor accepts for itself and in connection with its properties, generally and unconditionally, the non-exclusive jurisdiction of the aforesaid courts, and irrevocably agrees to be bound by any

Each Grantor hereby waives personal service of any and all process upon it and consents that all such service of process may be made by registered mail (return receipt requested) directed to Grantor at its address set forth in Section 16.6 of the Loan Agreement and service so made shall be deemed completed five (5) days after the same shall have been so deposited in the mails of the United States of America. Each Grantor waives the right to remove any judicial proceeding brought against any Grantor in any state court to any federal court. Any judicial proceeding by any Grantor against Agent or any Lender involving, directly or indirectly, any matter or claim in any way arising out of, related to or connected with this Agreement or any related agreement, shall be brought only in a federal or state court located in the County of New York, State of New York.




