**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

WHEREAS, OM Group, Inc., Cyantek Corporation, EPEP Holdings Company, LLC, OMG Americas, Inc., EaglePicher Medical Power, LLC, EaglePicher Technologies, LLC, Compugraphics U.S.A. Inc., OMG Electronic Chemicals, LLC, OMG Energy Holdings, Inc. and OMG Harko Holdings, LLC (collectively, the "Companies" and each, individually, a "Company") entered into (i) a Security Agreement, dated as of August 2, 2011 (as heretofore amended, modified or supplemented, the "Security Agreement") among the Companies and Bank of America, N.A., as Administrative Agent (the "Administrative Agent") and (ii) a Trademark Security Agreement, dated as of August 2, 2011 (as heretofore amended, modified or supplemented, the "Trademark Security Agreement" and, together with the Security Agreement, the "Agreements") among the Companies and the Administrative Agent, pursuant to which each Company granted a security interest (the "Security Interest") in all of such Company's right, title and interest in and to the Trademarks (as defined in the Security Agreement), including without limitation the trademarks and trademark applications set forth on the attached Schedule A, all to the extent set forth in the Agreements; and

WHEREAS, all of the obligations secured by the Security Interest have been fully paid and satisfied and the Administrative Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, without warranty or recourse of any kind; hereby releases its Security Interest held in the Trademarks listed on Schedule A annexed hereto, and hereby, (i) terminates all its rights, powers, privileges and remedies under the Agreements with respect to the Trademarks, (ii) re-conveys, re-transfers and sets over to the Companies any right, title or interest that the Administrative Agent may have acquired in the Trademarks, together with all the goodwill associated therewith, and (iii) releases each Company from all covenants, obligations, liabilities and warranties under the Agreements related to the Trademarks.
