**RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND  
COPYRIGHTS**

**THIS RELEASE OF SECURITY INTERESTS IN PATENTS, TRADEMARKS AND COPYRIGHTS** (this "Release") is made as of September 27, 2013 ("Effective Date") by **East West Bank**, a California banking corporation ("Secured Party"), in favor of **Iolo Technologies, LLC**, a California limited liability company ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Loan and Security Agreement dated May 28, 2013 (the "Loan and Security Agreement"), the Secured Party agreed to make loans and other credit extensions to Grantor;

**WHEREAS**, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, by and between Grantor and Secured Party, dated as of May 30, 2013 (the "Intellectual Property Security Agreement"), Grantor granted and pledged to Secured Party a security interest in and lien on all of Grantor's right, title and interest in, to the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement), including the Copyrights set forth on Schedule A attached hereto, the Patents set forth in Schedule B attached hereto, and the Trademarks set forth in Schedule C attached hereto (collectively, the "IP Collateral");

**WHEREAS**, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on July 16, 2013 at Reel/Frame 005079/0872 and at Reel/Frame 030872/0534; and

**WHEREAS**, Grantor has satisfied all of its Secured Obligations (as defined in the Loan and Security Agreement);

**WHEREAS**, Secured Party now desires to terminate and release the entirety of its security interest in the IP Collateral and provide a document suitable for recording in the United States Patent and Trademark Office and the United States Copyright Office evidencing and effecting the release, relinquishment and discharge of its security interest and continuing lien on the IP Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates the Intellectual Property Security Agreement, and hereby unconditionally and expressly terminates, cancels and releases any and all security interests or liens it has in, upon or against the IP Collateral. Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the IP Collateral.

If and to the extent the Secured Party has acquired any right, title or interest to any of the IP Collateral, it hereby assigns and transfers such rights, title or interest to the Grantor.


Secured Party shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without

limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.
