RELEASE OF TRADEMARK SECURITY INTEREST

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America, N.A., as lender, a national banking association (the "Lender"), whose address is 135 South LaSalle Street, Suite 925, Chicago, Illinois 60603 , pursuant to that certain Second Amended and Restated Loan and Security Agreement dated as of December 11, 2012, by and among EPIC Technologies, LLC, a Delaware limited liability company (the "Grantor"), the other Obligors from time to time party thereto, and the Lender for the Secured Parties referenced therein, (as the same may have been amended, modified, restated, or supplemented from time to time, the "Loan Agreement"; unless otherwise defined herein, all capitalized terms used herein shall have the respective meanings ascribed thereto in the Loan Agreement), does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under all intellectual property collateral identified in the Loan Agreement and the Trademark Security Agreement dated as of September 28, 2011 among the Lender and the Grantor (the "Trademark Security Agreement"), which such Trademark and Security Agreement and the obligations thereunder were reaffirmed pursuant to and in connection with the execution and delivery of the Loan Agreement, including the trademarks listed on Exhibit A attached hereto, (the "Released Collateral"), arising from the Loan Agreement and the Trademark Security Agreement, which was recorded in the United States Patent and Trademark Office ("PTO") on or about September 29, 2011, against the United States trademarks listed on Exhibit A at Reel/Frame Numbers 4632/0473. The Lender hereby releases, retransfers and reassigns to the Grantor the security interest and all of the Lender's right, title and interest in, to and under the Released Collateral. The Lender will execute and deliver, at the request and cost of the Grantor, such further instruments, documents and release forms as the Grantor may reasonably request to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

This Release of Trademark Security Interest shall be binding upon the Lender's legal representatives, assigns and successors. The Lender hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release of Trademark Security Interest.
