**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (the "Release") is executed as of October 11, 2013, by **GOLDMAN SACHS CREDIT PARTNERS L.P.**, as Collateral Agent for the Secured Parties under the Credit Agreement referred to below (in such capacity, the "Collateral Agent"), in favor of Mitchell International, Inc. (the "Grantor"). Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement referred to below.

WHEREAS, the Grantor entered into that certain Credit and Guaranty Agreement dated as of August 11, 2004 (as amended, amended and restated, or otherwise modified to the date hereof, the "Credit Agreement"), among the Grantor, the Collateral Agent and the other parties thereto; and

WHEREAS, pursuant to the Credit Agreement, the Grantor and the Collateral Agent executed a Grant of Trademark Security Interest (second lien) dated as of August 11, 2004 (as amended, amended and restated, or otherwise modified to the date hereof, the "Trademark Security Agreement") pursuant to which the Grantor granted to the Collateral Agent, among others, a continuing security interest in all of the Grantor's right, title and interest in and to the United States Trademark registrations and applications listed on Exhibit A hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby, and all rights to sue or otherwise recover for any past, present, or future infringement or other violation or impairment of any of the foregoing (the "Security Interest").

WHEREAS the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 16, 2004 at Reel 2916, Frame 0748.


WHEREAS the Collateral Agent has agreed to terminate and release its Security Interest as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Collateral Agent hereby releases, terminates and discharges the Security Interest granted under the Trademark Security Agreement, and any right, title or interest of the Collateral Agent in such Security Interest shall hereby terminate, cease and become void. The Collateral Agent hereby consents to the recording of this Release with the United States Patent and Trademark Office and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
