SUPPLEMENT NO. 1 TO TRADEMARK SECURITY AGREEMENT

BRIGHTON-BEST INTERNATIONAL, INC., a California corporation (“Grantor”) with offices located at 5855 Obispo Avenue, Long Beach, CA 90805, hereby acknowledges that it has granted to **PNC BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as Collateral Agent and a Joint Book Runner (“Collateral Agent”) with offices located at 2 North Lake Avenue, Suite 440, Pasadena, CA 91101, a security interest in and to all of Grantor’s right, title and interest in and to the trademarks and trademark registrations and applications therefor which are identified on Schedule I attached hereto and herein incorporated by this reference owned by Grantor (the “Trademarks”), together with the goodwill and assets of the business, as set forth in the Agreement (as such term is defined below).



Nothing contained in this Supplement No. 1 to Trademark Security Agreement shall be construed as a present or absolute assignment of any of the collateral or as limiting any interest which Secured Party may have in any other collateral described in the Agreement or otherwise.
