TERMINATION OF SECURITY INTEREST IN TRADEMARKS

THIS **TERMINATION OF SECURITY INTERESTS IN TRADEMARKS** dated as of October 18, 2013 (this “**Termination**”) is made by BARCLAYS BANK PLC, as collateral agent for the Secured Parties (the “**Collateral Agent**”) under that certain Trademark Security Agreement dated as of September 6, 2012 (as amended and in effect immediately prior to the date hereof, the “**Trademark Security Agreement**”) in favor of EXTENET SYSTEMS, INC., a Delaware corporation and I5 WIRELESS, LLC, an Illinois limited liability company (collectively, the “**Grantors**”).

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement, the Grantors granted a security interest to the Collateral Agent in all of such Grantor’s right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on Schedule A attached hereto (the “**Trademark Collateral**”);

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on September 10, 2012, at Reel 4858 and Frame 0023;

WHEREAS, the Grantors have requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “**Released Collateral**”);

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Collateral.


