GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, HITOUCH BUSINESS SERVICES LLC, a Delaware limited liability company ("HiTouch"), MYOFFICEPRODUCTS, LLC, a Delaware limited liability company ("MyOffice") and RENTACRATE LLC, a Delaware limited liability company ("Rentacrate"), in each case with offices at 74 Kenny Place Saddle Brook, New Jersey 07663 (HiTouch, MyOffice and Rentacrate are hereinafter referred to, individually, a "Grantor," and collectively, the "Grantors"), hereby grants to SALUS CAPITAL PARTNERS, LLC, with offices at 197 First Avenue, Suite 250, Needham, Massachusetts 02494 (the "Grantee"), a continuing security interest in the following: (i) all of such Grantor's right, title and interest in, to and under the United States trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications (the foregoing, collectively, the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Grant") is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantors, as such term is defined in the Security Agreement by, among others, the Grantors, the other Grantors from time to time party thereto and the Grantee, dated as of October 16, 2013 (as amended, modified, supplemented or restated hereafter, the "Security Agreement").

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

This Grant shall be governed by, and construed in accordance with the laws of the State of New York without regard to conflicts of laws principles thereof, but including Section 5-1401 of the New York General Obligations Law.




