RELEASE OF SECURITY INTERESTS IN TRADEMARKS

WHEREAS, C D Listening Bar, Inc., a California corporation ("Grantor"), has, pursuant to a Grant of Security Interest (Trademarks), dated June 30, 2004 (the "Security Agreement") recorded in the United States Patent and Trademark Office on August 26, 2004, at Reel 002931, Frame 0103, granted to PNC Bank, National Association, as agent ("Agent"), a security interest in and to all of Grantor's right, title and interest in and to the Collateral (as defined in the Security Agreement), including the trademarks specifically listed on Exhibit A attached hereto and the goodwill associated therewith; and

Agent acknowledges that this release may be filed along with any other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the release granted herein at the sole expense of Grantor. Agent, at the sole expense of Grantor, will execute such further documents as deemed reasonably necessary by the Grantor to confirm and effect this release.
