NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of October 19, 2013, is made by Bank of America, N.A., as collateral agent and administrative agent (in such capacities, the "Agent"), in favor of United Industries Corporation, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of November 7, 2011 (the "Security Agreement"), by the Grantor and the Agent, recorded in the United States Patent and Trademark Office at Reel 4656, Frame 0622, the Grantor assigned and granted to the Agent a security interest in Grantor's right, title and interest in and to the trademark listed on Exhibit A hereto (the "Trademark"), together with the goodwill of the business symbolized by the Trademark, the applications, registrations and records related to the Trademark and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (the "Released Assets"); and

WHEREAS, Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Assets;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release. The Agent hereby relinquishes, releases and discharges its security interest in the Released Assets and all right, title and interest of the Grantor in the Released Assets are hereby reassigned by the Agent to the Grantor.

2. Further Assurances. The Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the United States Patent and Trademark Office. The Agent further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or their agents or designees) reasonably request (at the Grantor's sole cost and expense) in order to confirm this Release and the Grantor's right, title and interest in, to and under the Released Assets.

3. Governing Law. This Release shall be governed by and construed and interpreted in accordance with the laws of the State of New York.

4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Security Agreement.
