Release of Grants of Trademark Security Interests

The Secured Party authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry, filing of Uniform Commercial Code financing statements and the filing or recording of any other document or instrument necessary to place on record the release of the Secured Party's security interest in all of the Grantors' right, title and interest in and to the Released Collateral.

The Secured Party agrees to provide the Grantors with any additional authorization necessary to effect the release of its security interest in the Released Collateral or any other security interest granted under the Agreement.
