PATENT AND TRADEMARK SECURITY AGREEMENT

THIS PATENT AND TRADEMARK SECURITY AGREEMENT (this "**Agreement**") is entered into as of November 8, 2013 by Backyard Products, LLC, a Delaware limited liability company ("**Borrower**"), Backyard Storage Solutions, LLC, a Delaware limited liability company, Backyard Services, LLC, a Delaware limited liability company, Backyard Play Systems, LLC, a Delaware limited liability company, Backyard Services Canada, LLC, a Delaware limited liability company, Backyard Kids, LLC, a Delaware limited liability company, Backyard Swing-N-Slide Play Systems, LLC, a Delaware limited liability company, Backyard Swing-N-Slide Play Systems Real Estate, LLC, a Delaware limited liability company, Backyard DISC Company, Inc., a Michigan corporation, and Backyard Products Canada Co., a Canadian corporation (together with the Borrower, collectively, the "**Grantors**"), in favor of JPMorgan Chase Bank, N.A., a national banking association (the "**Lender**").

Recitals

A. The Borrower, the other Loan Parties from time to time party thereto, and the Lender have entered into a Credit Agreement dated on or about the date hereof (as amended, supplemented, restated or otherwise modified from time to time, the "**Credit Agreement**"), pursuant to which the Lender has made available to the Borrower credit facilities.

B. In connection with the Credit Agreement, the Grantors and the Lender have entered into a Pledge and Security Agreement dated on or about the date hereof (as amended, supplemented, restated or otherwise modified from time to time, the "**Security Agreement**"), pursuant to which certain Secured Obligations owed to the Lender are secured. Pursuant to the terms of the Security Agreement, the Grantors are required to execute and deliver to the Lender this Agreement.

Agreement

In consideration of the recitals set forth above and the mutual agreements contained herein and in the Credit Agreement and the other Loan Documents, each Grantor hereby grants to the Lender to secure the Secured Obligations, a continuing security interest in all of such Grantor's right, title and interest in, to and under the following, whether now owned by or owing to, or hereafter acquired by or arising in favor of such Grantor (including any trade name or derivations thereof):

- (1) any and all patents registrations and patent applications, including, without limitation, each patent and patent application referred to in Schedule 1 attached hereto, together with any renewal thereof;
- (2) all products and proceeds of the foregoing, including, without limitation, any and all claims by the Grantor against third parties for past, present or future infringement of any patent, including, without limitation, any patent referred to in Schedule 1 attached hereto and any patent issued pursuant to a patent application referred to in Schedule 1 attached hereto (items 1 and 2 being herein collectively referred to as the "**Patent Collateral**");

- (3) each trademark and trademark application, including without limitation, each trademark and trademark application referred to in Schedule 2 attached hereto, together with any reissues, continuations or extensions thereof and all goodwill associated therewith;
- (4) all products and proceeds of the foregoing, including without limitation, any claim by the Grantor against third parties for past, present or future infringement of any trademark, including without limitation, any trademark referred to in Schedule 2 attached hereto and any trademark issued pursuant to a trademark application referred to in Schedule 2 attached hereto (items 3 and 4 being herein collectively referred to as the “*Trademark Collateral*”).


The security interests granted to the Lender herein are granted in furtherance, and not in limitation of, the security interests granted to the Lender pursuant to the Security Agreement; provided, however, that nothing in this Agreement shall expand, limit or otherwise modify the security interests granted in the Security Agreement. Each Grantor acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Patent Collateral and Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern. All capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Credit Agreement. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic imaging shall be effective as delivery of a manually executed counterpart of this Agreement.


