**AMENDMENT NO. 1 TO  
TRADEMARK SECURITY AGREEMENT**

THIS AMENDMENT NO. 1 to Trademark Security Agreement is dated as of November 27, 2013 (this "Amendment") and is made by and between SIERRA DESIGNS ACQUISITION COMPANY, LLC, a Delaware limited liability company, f/k/a Sierra Designs Acquisition Corporation, a Delaware corporation, AMERICAN RECREATION PRODUCTS, LLC, a Delaware limited liability company, f/k/a American Recreation Products, Inc., a Delaware corporation, KELLWOOD COMPANY, LLC, a Delaware limited liability company, f/k/a Kellwood Company, a Delaware corporation, and PHAT FASHIONS LLC, a New York limited liability company (collectively, jointly and severally, "Grantors", and each, individually, "Grantor"), and WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as Agent for the Lenders and the Secured Parties (in such capacity, together with its successors and assigns in such capacity, "Agent").

WHEREAS, Grantors and Agent entered into that certain Trademark Security Agreement dated as of October 19, 2011 (as amended, restated, supplemented, or otherwise modified from time to time, the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was duly recorded in the United States Patent and Trademark Office on October 19, 2011, Reel/Frame: 004644/0496;

WHEREAS, since the date of the Grantors' execution of the Trademark Security Agreement, Grantors have acquired interests in certain additional Trademarks, all of which are listed on Schedule A hereto (the "New Trademarks"); and

WHEREAS, in accordance with Section 5 of the Trademark Security Agreement, the parties hereto agree to amend the Trademark Security Agreement to confirm the inclusion of such New Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the parties hereto hereby agree to amend the Trademark Security Agreement as follows:

1. Definitions. All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to them in the Trademark Security Agreement.

2. Security Interest in New Trademarks. To secure the Secured Obligations, each Grantor hereby grants and pledges to Agent, for the benefit of the Secured Parties, and hereby reaffirms its prior grant pursuant to the Security Agreement and the Trademark Security Agreement of, a continuing security interest in such Grantor's right, title and interest in and to the Trademark Collateral, whether now owned or hereafter acquired or arising, including the New Trademarks.

3. Supplemented Schedule A. Schedule I of the Trademark Security Agreement is hereby supplemented to add the New Trademarks.


4. Effect of Amendment. Except as expressly amended by this Amendment, the terms of the Trademark Security Agreement shall remain in full force and effect as executed.




