ACKNOWLEDGEMENT OF CONTINUING TRADEMARK SECURITY INTEREST

This ACKNOWLEDGEMENT OF CONTINUING TRADEMARK SECURITY INTEREST, dated as of November 26, 2013, by NEW YORK MINT, LLC, a Delaware corporation in favor of U.S. BANK NATIONAL ASSOCIATION, in its capacity as Administrative Agent (the "Agent") for the Lenders (as defined in the Credit Agreement referenced below).

WITNESSETH:

WHEREAS, on November 4, 2013, Asset Marketing Services, Inc. assigned to New York Mint, LLC the trademark registrations identified on Schedule I;

WHEREAS, on November 12, 2013, the assignment was recorded with the Trademark Division of the United States Patent and Trademark Office ("PTO") against the trademark registrations identified on Schedule I at Reel 5152, Frame 0422;

WHEREAS, AMS Holding, LLC, a Delaware limited liability company ("Holdings"), Asset Marketing Services, Inc., a Minnesota corporation ("AMS"), Nextten Stauer, LLC, a Minnesota limited liability company ("Stauer"), Metrix Media, LLC, a Minnesota limited liability company ("Metrix") and New York Mint, LLC, a Delaware limited liability company ("NYM," and together with Holdings, AMS, Metrix and Stauer, each a "Borrower" and collectively, the "Borrowers"), the lenders party thereto (the "Lenders"), and the Agent have entered into an Amended and Restated Credit Agreement dated November 26, 2013 (as amended, supplemented, extended, restated or otherwise modified from time to time, the "Credit Agreement") pursuant to which the Lenders have agreed, among other things, to extend to the Borrowers certain credit accommodations;

WHEREAS, Borrowers, the Lenders, and the Agent have entered into a Pledge and Security Agreement and Irrevocable Proxy dated October 4, 2012, (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Asset Marketing Services, Inc., executed and delivered to the Agent a Confirmatory Grant of Security Interest in United States Trademarks ("Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office on October 5, 2012, at Reel 4875, Frame 0483;

NOW, THEREFORE, the undersigned parties declare the following:

1. The Trademark Security Agreement is continuing and valid in all respects.
2. New York Mint, LLC is now regarded as the Grantor under the Trademark Security Interest.


