**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY RIGHTS**

This TERMINATION AND RELEASE is made as of December 16, 2013, by CNM Acquisition LLC ("Releasor"), as successor in interest to Ableco Finance LLC, in favor of U.S. Natural Resources, Inc. ("Debtor").

Recitals

A. Pursuant to a security agreement dated October 14, 2004, made in favor of Ableco Finance LLC (the "Security Agreement"), a security interest (the "Security Interest") was granted to Ableco Finance LLC in certain intellectual property, including, without limitation, trademarks and patents and the items listed on Schedule A (the "IP Collateral");

B. Pursuant to the Security Agreement, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on February 8, 2005 and in the Patent Division of the United States Patent and Trademark Office on December 6, 2004 and February 9, 2005.

C. Pursuant to an Asset Purchase Agreement dated June 4, 2008, Releasor purchased the Security Interest.

D. The Releasor now desires to terminate and release the entirety of its Security Interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Releasor hereby states as follows:


1. Release of Security Interest. The Releasor hereby terminates, releases and discharges its Security Interest in the IP Collateral.

2. Further Assurances. The Releasor hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
