THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "*Trademark Termination and Release*") dated as of December ~~23~~ 2013, from BANK OF AMERICA, N.A., in its capacity as administrative agent (the "*Collateral Agent*") pursuant to an Intellectual Property Security Agreement Supplement (the "*Supplement*") dated as of January 28, 2004 between Stewart Enterprises, Inc., a Louisiana corporation (the "*Grantor*") and the Collateral Agent.

WITNESSETH:

WHEREAS, pursuant to the Supplement a security interest (the "*Security Interest*") was granted by the Grantor to the Collateral Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Supplement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 18, 2004 at Reel 002930, Frame 0772;

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:


1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks set forth on Schedule I hereto.

2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.
