**TERMINATION AND RELEASE OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "***Trademark Termination and Release***") dated as of December 23, 2013, from BANK OF AMERICA, N.A., in its capacity as administrative agent (the "***Collateral Agent***") pursuant to a Notice and Confirmation of Grant of Security Interests in Trademarks (the "***Agreement***") dated as of October 9, 2012 between Stewart Enterprises, Inc., a Louisiana corporation (the "***Grantor***") and the Collateral Agent.

WITNESSETH:

WHEREAS, pursuant to the Agreement a security interest (the "***Security Interest***") was granted by the Grantor to the Collateral Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 17, 2012 at Reel 4882, Frame 0869;

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "***Specified Trademark Collateral***", as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks set forth on Schedule I hereto.

2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.

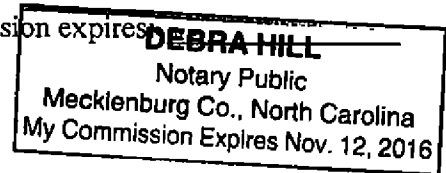
