**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY INTEREST**

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of December 31, 2013 (“Release Date”), by and between U.S. Bank National Association, as administrative agent under the Credit Agreement (as defined below) (the “Secured Party”) and Edgewood Partners Insurance Center (the “Company”).

WHEREAS, pursuant to the terms of (i) the Credit Agreement, dated as of June 1, 2012, among the Company, Edgewood Partners Holdings LLC (“Parent”), the Secured Party and the lenders party thereto from time to time (the “Credit Agreement”), (ii) the Security Agreement, dated as of June 1, 2012, among the Company, Parent, the grantors party thereto and the Secured Party, and (iii) the Trademark Security Agreement, dated as of June 1, 2012, between the Company and the Secured Party recorded with the United States Patent and Trademark Office (“USPTO”) on June 6, 2012 at Reel 004796, Frame 0112, and the Trademark Security Agreement, dated as of June 1, 2012, between Powerguard Specialty Insurance Services LLC and the Secured Party recorded with the USPTO on July 11, 2013 at Reel 5068, Frame 0462 (collectively, the “Trademark Security Agreements”), the Company granted to the Secured Party a security interest in and lien on all of the Company’s Trademark Collateral (as defined in the Trademark Security Agreements), including, without limitation, the trademarks identified on Schedule I attached hereto; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest and all of its right, title and interest in the Company’s Trademark Collateral as herein provided;

NOW, THEREFORE, as of the Release Date, the Secured Party hereby terminates and releases its security interest in and first priority lien on all of the Company’s Trademark Collateral and the goodwill associated therewith.
