**TRADEMARK ASSIGNMENT**

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made to be effective this 5<sup>th</sup> day of December, 2013, by and between Chatterm, Inc., a Tennessee corporation ("Assignor"), and N.V.E. Inc., a New Jersey corporation ("Assignee"). Capitalized terms used herein and not defined shall have the meaning assigned to them in the Purchase Agreement (as defined below).

**WITNESSETH:**

WHEREAS, Assignor and/or its Affiliates are engaged either directly or through third parties in the business of developing, manufacturing, marketing, and selling a line of products (the "Products") known as the Dexatrim® product line in the United States of America (the "Product Line") through the use of the trademarks and trade names associated with the Products that are owned by Assignor and/or its Affiliates;

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase and Sale Agreement dated December 5, 2013 (the "Purchase Agreement"), pursuant to which Assignor has agreed to sell and transfer, and Assignee has agreed to purchase and acquire, certain assets and liabilities relating to the Product Line; and

WHEREAS, in connection with the Purchase Agreement, Assignor has agreed to transfer, convey, and assign all of Assignor's rights, title, and interest in and to the trademarks and trade names and all applications and registrations of the foregoing set forth on Exhibit A, attached hereto, together with the goodwill associated therewith (the "Product Trademarks").

NOW, THEREFORE, for ten dollars (\$10.00) and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged:

Assignor does hereby irrevocably assign, transfer, convey and deliver to Assignee, and Assignee hereby accepts, all right, title and interest of Assignor in and to the Product Trademarks, including the related common-law rights and all good will associated therewith.

Assignor authorizes and requests the United States Patent and Trademark Office and the equivalent office in each country in which Product Trademarks are registered to record Assignee as the assignee and owner of the Product Trademarks and to issue any trademarks which may be granted on any applications included in the Product Trademarks to Assignee as assignee of the entire right, title and interest therein and thereto.

Assignor agrees that it shall cooperate with Assignee to execute further documentation and to take further actions as may be reasonably required under local laws and regulations to effectuate and record this Assignment, all at Assignee's sole cost and expense. In connection with the foregoing, Assignor agrees, at Assignee's sole cost and expense, to take such further reasonable actions and to execute any reasonably required powers of attorney, applications, assignments, declarations, affidavits and other papers. This obligation shall expire on June 6, 2014.

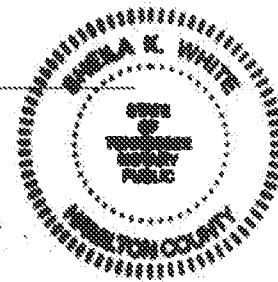

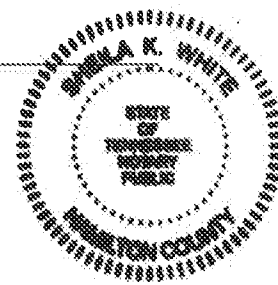
