RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (the "Release") is made as of December 27, 2013, by ALLIED SYSTEMS HOLDINGS, INC., CT SERVICES, INC. and AXIS GROUP, INC. on behalf of the Secured Parties defined below in favor of ALLIED SYSTEMS HOLDINGS, INC., CT SERVICES, INC. and AXIS GROUP, INC. (collectively, the "Grantors").

WHEREAS, the Grantors executed one or more Trademark Security Agreements and Copyright Security Agreements, each dated May 29, 2007 in favor of CIT GROUP/BUSINESS CREDIT, INC. and GOLDMAN SACHS CREDIT PARTNERS L.P., as the respective secured parties (each, a "Secured Party") (collectively, as amended, supplemented or otherwise modified from time to time, the "IP Security Agreements"), pursuant to which the applicable Grantor has granted to the applicable Secured Party a security interest in, among other things, its rights in the trademark and service mark registrations and applications set forth in Schedule A hereto, in each case, together with the goodwill associated therewith and symbolized thereby (collectively, the "Trademarks") and the copyright registrations and applications set forth in Schedule B hereto (the "Copyrights");

WHEREAS, the IP Security Agreements were recorded with the Trademark Division of the United States Patent and Trademark Office and the U.S. Copyright Office, as applicable;

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of September 12, 2013 (as amended from time to time, the "Purchase Agreement"), by and among Jack Cooper Holdings Corp., as Purchaser, and Allied Systems Holdings, Inc. and certain Subsidiaries of Allied Systems Holdings, Inc. party thereto, as Sellers, the Grantors, on or about the date hereof, transferred and sold certain Purchased Assets (as defined therein) including, without limitation the Trademarks and the Copyrights, to the Purchaser (as defined therein), free and clear of all liens and encumbrances; and

WHEREAS, pursuant to the Sale Order (as defined in the Purchase Agreement) of the United States Bankruptcy Court for the District of Delaware, the Grantors, as Debtors, are authorized to execute, file, and deliver any lien releases with respect to the Purchased Assets to evidence the sale of the Purchased Assets free and clear, including, without limitation, this Release.

ACCORDINGLY, THE GRANTORS, on behalf of the Secured Parties, hereby acknowledge and agree as follows:

1. Purchased Assets. Each Grantor represents and warrants that the Trademarks and the Copyrights constitute Purchased Assets.
2. Release of Security Interest. Each Grantor, on behalf of the applicable Secured Party, hereby terminates and releases such Secured Party's liens on and security interests in the Trademarks and the Copyrights, and hereby assigns and transfers to the applicable Grantor (as indicated on Schedule A or Schedule B, as applicable), without any representation, warranty or

recourse whatsoever, such Secured Party's entire right, title and interest in and to each of the Trademarks and Copyrights, effective as of the date set forth above.

3. Recordation. Each Grantor authorizes and requests that the Commissioner for Trademarks, the Commissioner for Copyrights, and any other applicable government officer record this Release.


4. Further Instruments. Each Grantor hereby agrees to execute such further instruments and documents and perform such further acts as each Grantor or the Purchaser may deem necessary to convey to such Grantor the rights herein conveyed.

5. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.




