[REDACTED] REUSEIT, LLC, a Delaware limited liability company, having an address of 7021 Wolftown-Hood Rd, Madison, VA 22727 ("ReUseIt") ([REDACTED]) ReUseIt are hereinafter referred to, individually, a "Grantor," and collectively, the "Grantors", hereby grant to WELLS FARGO BANK, NATIONAL ASSOCIATION, with offices at One Boston Place, 19th Floor, Boston, Massachusetts 02108 (the "Grantee"), a continuing security interest in the following: (i) all of such Grantor's right, title and interest in, to and under the United States trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications (the foregoing, collectively, the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below), (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (the foregoing, collectively, the "Trademark Collateral").

THIS GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Grant") is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantors, as such term is defined in the Security Agreement by, among others, the Grantors, the other Grantors from time to time party thereto and the

Grantee, dated as of January 6, 2014 (as amended, restated, supplemented or otherwise modified and in effect from time to time, the "Security Agreement").

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

This Grant shall be governed by, and construed in accordance with, the law of the State of New York, without giving effect to conflict of laws principles thereof, but including Section 5-1401 of the New York General Obligations Law.


