**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN PATENTS, TRADEMARKS AND COPYRIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS ("Agreement") dated as of January 16, 2014, from PNC Bank, National Association, a US, National Association ("Secured Party"), in favor of AP Exhaust Technologies, LLC (successor of AP Exhaust Technologies, Inc.) ("Grantor").

WITNESSETH:

WHEREAS, in connection with the Patent, Trademark and Copyright Security Agreement dated March 28, 2013 ("Intellectual Property Security Agreement"), Secured Party was granted a security interest in all of its right, title and interest in, to and under all Patents, Trademarks and Copyrights (as defined in the Intellectual Property Security Agreement) from AP Exhaust Technologies, Inc.;

WHEREAS, the Intellectual Property Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on March 28, 2013 at Reel 4993 and Frame 0498 and in the Patent Assignment Division of the United States Patent and Trademark Office on March 28, 2013 at Reel 30106 and Frame 0933; and

WHEREAS, Security Party now wishes to release its liens on, and security interests in, the Patents, Trademarks and Copyrights (including the patents and trademarks as set forth on Schedule A attached hereto).

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Secured Party hereby agrees as follows:

1. Release of Security Interest. Secured Party hereby terminates, releases and discharges all of its security interest in the Patents, Trademarks and Copyrights, and reassigns any and all right, title and interest that it may have in or to the Patents, Trademarks and Copyrights to Grantor.
2. Recordation. Grantor or its authorized agent is authorized to record this Agreement with the United States Patent and Trademark Office.
3. Governing Law. This Agreement and the rights and obligations of the parties under this agreement shall be governed by, and construed and interpreted in accordance with, the law of North Carolina, but giving effect to federal laws applicable to national banks.
4. Further Assurances. Secured Party shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor, and at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Agreement.
