**RELEASE OF SECURITY INTERESTS AND SECURITY AGREEMENTS  
WITH RESPECT TO PATENTS, TRADEMARKS AND COPYRIGHTS**

**THIS RELEASE OF SECURITY INTERESTS IN PATENTS, TRADEMARKS AND COPYRIGHTS** (this "Release") is made as of December 19, 2013 ("Effective Date") in favor of Airborne Systems North America of NJ Inc., a New Jersey corporation, located at 5800 Magnolia Avenue, Pennsauken, NJ 08109 ("Grantor") by PNC Bank, National Association (the "Administrative Agent"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

**WHEREAS**, Grantor and the Administrative Agent entered into that certain Patent, Trademark and Copyright Security Agreement by and between Grantor, the Administrative Agent and the Lenders thereto dated December 23, 2011 (the "Security Agreement"), wherein Grantor granted to the Administrative Agent, for the benefit of the Administrative Agent and the Lenders, a security interest in and to all of the Grantor's Patents, Trademarks and Copyrights, including the items set forth on Exhibits A and B hereto (collectively, the "Collateral").

**WHEREAS**, Grantor and Administrative Agent entered into that certain Grant of Security Interest in Patents, Trademarks and Copyrights dated December 23, 2011 (the "IP Security Agreement"), which was recorded with the United States Patent and Trademark Office (the "USPTO") on January 9, 2012 (1) at Reel 4694, Frame 0167, for the purposes of recording security interests with respect to the trademarks of the Grantor, including those items set forth on Exhibit A hereto, and (2) at Reel 027500, Frame 0415, for the purposes of recording security interests with respect to the patents of Grantor, including those items set forth on Exhibit B hereto; and


**WHEREAS**, Grantor has paid all of its outstanding indebtedness to the Administrative Agent and requests a specific release of the security interest granted and recorded against the Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the IP Security Agreement and releases and re-assigns to Grantor any and all liens, security interests, or other right, title and interest it may have in, to and under the Collateral, together with the goodwill of the business symbolized thereby, including (a) all security interests pledged and granted to the Administrative Agent by the Grantor in the agreements and documents recorded with the USPTO on January 9, 2012 at Reel 4694, Frame 0167, including but not limited to the security interest in the trademarks and/or trademark applications described on Exhibit A attached hereto, and (b) all security interests pledged and granted to the Administrative Agent by the Grantor in the agreements and documents recorded with the USPTO on January 9, 2012 at Reel 027500, Frame 0415, including but not limited to the security interest in the patents and/or patent applications described on Exhibit B attached hereto.

The Administrative Agent acknowledges that no demand was made upon the Grantor, so no assignment of the Collateral was ever made.
