RELEASE OF TRADEMARK SECURITY AGREEMENTS

THIS RELEASE OF TRADEMARK SECURITY AGREEMENTS (this "Release") is made as of December 27, 2013 (the "Effective Date"), by UBS AG, STAMFORD BRANCH, as collateral agent (in such capacity, the "Collateral Agent"), in favor of LOCAL TV ALABAMA, LLC, LOCAL TV ARKANSAS, LLC, LOCAL TV ILLINOIS, LLC, LOCAL TV IOWA, LLC, LOCAL TV OKLAHOMA, LLC, LOCAL TV PENNSYLVANIA, LLC, LOCAL TV TENNESSEE, LLC and LOCAL TV VIRGINIA, LLC, each a Delaware limited liability company (each, a "Pledgor" and collectively, the "Pledgors").

WHEREAS, pursuant to the terms and conditions of those certain Trademark Security Agreements among the Pledgors and the Collateral Agent set forth on Schedule I hereto (collectively, the "Trademark Security Agreements"), the Pledgors pledged and granted to the Collateral Agent a lien on and security interest in all of their respective right, title and interest in and to certain collateral identified in said Trademark Security Agreements including, without limitation, the trademark and service mark registrations and applications set forth on Schedule II hereto, along with the goodwill associated therewith (collectively, the "Trademarks");

WHEREAS, the Trademark Security Agreements were recorded with the Assignment Division of the U.S. Patent & Trademark Office as set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreements, and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Trademarks arising under the Trademark Security Agreements.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Trademarks, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Pledgors.


