TRADEMARK RELEASE

TRADEMARK RELEASE, effective as of this 27th day of December, 2013, given by Deutsche Bank Trust Company Americas, as Collateral Agent ("Agent") with principal offices at 60 Wall Street, New York, NY 10005, to Community Television of North Carolina, LLC, a Delaware limited liability company ("Grantor"), with principal offices at 201 Main Street, Ft. Worth, TX 76102, as follows:

W I T N E S S E T H

WHEREAS, the Grantor has heretofore granted to the Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Secured Obligations (as defined in that certain Security Agreement, dated as of July 14, 2008, between the Agent and the Grantor (the "Security Agreement"));

WHEREAS, the Grantor and the Agent are party to that certain Trademark Security Agreement, dated as of July 14, 2008 (as amended and/or supplemented from time to time, the "Trademark Security Agreement"), which was duly recorded on August 7, 2008, at Reel 3830, Frame 0885 in the United States Patent and Trademark Office; and


WHEREAS, the Agent wishes to release its security interest in (i) the Marks, (ii) all Goodwill (as defined in the Trademark Security Agreement) associated with the Marks, and (iii) all Proceeds (as defined in the Trademark Security Agreement) of any and all of the foregoing ((i), (ii) and (iii) collectively, the "Trademark Collateral") and restore all right, title and interest in and to the Trademark Collateral to the Grantor and to dissolve any and all Liens (as defined in the Security Agreement) and encumbrances respecting the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto

the Grantor (without recourse, representation or warranty of any kind (either express or implied))
the security interest in and lien on the Trademark Collateral granted to Agent by the Grantor
pursuant to the Trademark Security Agreement.
